a. Catherine Barretta moved to receive the Treasurer's Report. Jody Ruggiero seconded it. The report was received.

II. President's Report: Melanie Davidoff

- **a.** Melanie advised that the Covid relief fund, that was used to assist individuals with NCLA membership dues, has been exhausted and thanked the anonymous donor who made the fund possible. The board is looking at options to continue to help people who are experiencing financial hardships.
- **b.** Melanie moved to appoint two new co-chairs of the Pop Culture Committee: Jenn Jordan (Syosset Public Library), and Kyle Fichtner (Bryant Public Library). Catherine Barretta seconded.
- **c.** Melanie let everyone know that the *Free for All: The Public Library* PBS documentary was shown at the Port Washington Public Library, and was inspiring. Libraries are able to do a screening through PBS or Indie Lens.

III. <u>Division Reports</u>

a. Academic & Special Libraries: James Mantegna

- i. We are getting ready for the Herb Biblo Invitational Library Conference on April 24th, which will be held at Nassau Community College. Our speakers will be presenting on various aspects of Artificial Intelligence and Generative AI, from classroom and ethical issues (presented by Daniel Fernandez of the NCC Philosophy department), to actual student habits related to large language models, as revealed in a survey conducted by Megan Marchese of Farmingdale State College); to the implications of AI in institutional research design (by Gwendolyn Reece of American University).
- ii. The Academic & Special Libraries Division is sponsoring two programs for the Long Island Library Conference. Our Fall Roundtable was held in December much later than usual and featured Summer Buffin from NYIT presenting on the use of TTRPG Table Top Role Playing Games to connect with students and patrons in various library settings to increase engagement and information literacy. The attendance was better than expected for that Roundtable, and attendees had an interest in learning more, so we suggested to Summer that she propose a program for the Long Island Library Conference, which was accepted, so we are working on a format for her presentation, Initiating Life-long Patron Relationships with the Library Through TTRPG. The presentation has an early slot in

- the Roosevelt Room of the Melville Marriot. The second program we are sponsoring will be presented by Danielle S.Apfelbaum and Samuel Horstmann from Farmingdale State University, and Derek Stadler of LaGuardia Community College. The title is: Demystifying Mentoring: Mentees and Mentors on Participating in a Professional Mentoring Program
- iii. We are also formulating our Spring Roundtable, a virtual event for Academic Librarians. We are planning on a tentative date of Friday, May 2nd (the week before the Long Island Library conference) and will feature Selenay Atyac from Long Island University, discussing research that she and a number of colleagues published on the topic of best practices in information literacy. The title of the article: An Exploration of Teaching Strategies Used by Librarians: Cases in Information Literacy Instruction by High School and College Librarians.
- b. Children's Services: Tamelee Young (Absent with Notice), No report.
- c. Media Services: Natasha Drax (Absent with Notice)
 - i. We will be holding our first Roundtable event on Zoom on April 29th at 2 p.m. Up for discussion is the streaming experience: services, practices, and issues.
 - ii. Our next board meeting will be on Tuesday, April 14th at 2 p.m.
 - iii. Swank has just announced their own streaming platform for librarians and will be holding an information session on April 16th. Natasha will forward this email to the NCLA listsery.

d. Programming & Public Relations: Marion Dodson

- We had our first official 2025 board meeting on Zoom on Friday, March 21st. It was a great meeting and a lot was accomplished including setting the dates for future board meetings and three Programming Roundtable discussions.
- ii. The first Programming Roundtable of the year will be on Wednesday, April 23rd at 2:30 p.m. at NLS. Registration is open and going well. There are still spaces left. It is free for NCLA members and \$15 for non-members. CEUs will issued to all who attend.

e. Reference & Adult Services: Martha DiVittorio

- i. We had a very successful virtual program on May 25th: Carol Fitzgerald's (*Bookreporter*) Best Bets & Sleeper Hits 2025. A total of 53 people registered and NCLA received \$45 from non-member registrations. We had about 32 people on the Zoom and sent a link to the recording to everyone who registered.

- 3. Lastly, RASD will have a relaxation-themed raffle basket including self-care items, paint by numbers, and wine.
- iii. The Division is working on programs for the Fall please stay tuned.

f. Support Staff Division: Eric Gaertner (Absent with Notice)

- i. We are holding our first class this year in 2 weeks at NLS with Nicole Scherer, NLS Assistant Director, as the speaker. There will be a morning and an afternoon session. So far approximately 30 people are registered.
- ii. We started the process to make a new banner/tablecloth for our division.
- iii. We are in talks of setting up a facilities class to demo some machines, show new products and hold a meet and greet with the other facilities members. We hope we have a good turnout for that.

g. Young Adult Services: Shannon Dalrymple (Absent with Notice)

- i. We'll be hosting an informal social meet-up on April 11th at the Round One arcade in Hicksville. Everyone is welcome to attend! About 15 people are registered so far.
- ii. The Division will be moving the BEST Award to match Suffolk's YASD's timeline, so it will now be given at the annual December Brunch instead of the Long Island Library Conference. Both Divisions believe it will allow more students the opportunity to attend and receive the award in-person.
- iii. The Division is planning its annual June Brunch.

IV. COMMITTEE REPORTS:

- a. Annual Dinner: Dalal Fatoush (Absent), Chris Marra (Absent with Notice), Barbara Mickowski (Absent)
 - i. As requested by the NCLA membership, we are planning to hold the 2025 Annual Dinner/Installation of Officers at the Coral House in the Colonial Skylight Room (same room as last year/main level) on Thursday, December 4th. We are in the process of finalizing the contract. With this contract we would need to guarantee 75 attendees this is the same amount as in the past and is common among many venues. We have always exceeded this amount, and we are hopeful to do the same this year. The cost of the contract is \$5 per person more than last year (+fees/tips). This seems fair to us for what we are getting. We will be locking in this price as prices are going up everywhere. We will try to keep the cost to attendees as close as possible to last year's cost. A check for the deposit needs to be issued.

- ii. We are looking forward to celebrating with everyone on Thursday, December 4th at the Coral House!
- iii. Syntychia thanked the committee for their hard work and for setting the date far enough in advance to allow people to plan accordingly.
- iv. Art commented that he hopes to see incoming Division presidents attend so they can be installed at the dinner.

- c. Civil Service: Mamie Eng
 - i. Caroline Ashby, Director of NLS, Nicole Scherer, several library directors, a few trustees, and Mamie met with the new Executive Director of Nassau County Civil Service, Carnell Foskey, and staff on April 8, 2025. He has agreed to entertain a residency waiver for Librarian I candidates for a two-year pilot program, pending the Civil Service Board's approval.
 - Other topics such as credit for Librarian Trainees, non-competitive positions, and promotions were mentioned, but no action is being considered at this point.

n. Legislation: Frank McKenna (Absent with Notice)

- i. As of April 10, 2025 the NYS Budget has not been approved by the legislature.
- ii. The Trump Administration and DOGE intends to cut funding for the federal Institute for Museum and Library Services to the lowest possible legal levels. These proposed cuts would have a hugely negative impact on the services, programs and collections of the New York State Library and the administration of the Construction Aid program among many other negative impacts.

o. Library Staff of Color: Syntychia Kendrick-Samuel, Michelle Samuel, and Egita Johnson-Guillame (Absent)

i. The committee will be presenting "Succession Planning to Build Future Leaders" at the LILC.

- ii. Syntychia advised that the Black Caucus of ALA released the names of the 2025 Literary Award winners. She will share the press release on the NCLA listserv. She further advised that public libraries have the opportunity to stand up and make sure these books are in our collections, particularly at a time when such voices are being removed and silenced.
- iii. Syntychia discussed LILRC's recent meet and greet with ALA President Cindy Hohl. It was a moving presentation, and the committee will be bringing such light and positivity into their work.

- i. We are excited about the conference on Thursday May 8. We have a meeting later today to go over the food options and floor plans for the conference. All tables must be staffed throughout the day. The committee has noticed if tables are left unattended.

- iii. Jan advised that she knows the committee will be looking for a bridge loan until receipts from the online registration are received. Her recommendation is to approve a loan, but maybe wait to see how much the conference account has in it a week before the payment is due. She would also like to clarify if NCLA will be writing the check directly to the Marriott, and, payment from NCLA should be for the difference needed to pay the conference invoice, not the entire invoice.
- iv. Martha DiVittorio advised that payment is due May 1 and that the conference may still need a bridge loan.
- v. Syntychia asked if a committee/division wants to do a raffle, do they also need a whole table? Melanie advised that some groups chose to have the raffle at the main NCLA table, or at another division table that is willing to host the raffle. Melanie further advised that NCLA cannot have raffles from all the divisions at the main NCLA table because there's only so much space.

They also said this issue can be revisited for a permanent waiver and additional titles in a year or so.

c. Nassau Library System: Lisa Zuena

i. Thank you to the libraries who participated in our Spirit Week campaign to celebrate National Library Week this year. Several libraries posted photos of their staff in various costumes, celebrating their favorite fandoms, and celebrating the books that made them readers.

d. Nassau BOCES School Library System: Mildred Bernstein

- i. Nassau BOCES School Library System is almost finished with the agenda for their May 12 liaison meeting. We are excited to start the meeting by presenting the NBSLS Administrator of the Year and the NBSLS School Librarian of the Year, voted for by the Nassau County School Librarians. Following the award ceremony, we will have a breakout room for the three levels of school librarians to share lesson plans with each other. The end of year procedure instruction is the last session before lunch. After lunch we will have some vendor demonstrations and a reader's advisory presentation by Arlene LaVerde, Adjunct Profession at Queens College. We have over 80 librarians signed up and are excited for the last liaison meeting of the year.
- ii. Our April 25 College/University-High School meet-up will be held at 9:00am. We have 5 College/University librarians attending with about 10 school librarians. Our May 28th meet-up will be in the afternoon.
